**ON THE ESTABLISHMENT OF THE CAMBODIAN COUNTER**  
**COUNTERFEIT COMMITTEE**

**ROYAL GOVERNMENT**

- Having seen the Constitution of the Kingdom of Cambodia;
- Having seen Royal Decree No. NS/RKT/0823/1981 dated 22 August 2023 on the Appointment of the Royal Government of the Kingdom of Cambodia;
- Having seen Royal Kram No. NS/RKM/0618/012 dated 28 June 2018 promulgating the Law on the Organization and Functioning of the Council of the Ministers;
- Having seen Royal Kram No. NS/RKM/0196/08 dated 24 January 1996 promulgating the Law on Establishment of the Ministry of Interior;
- Having seen the Sub-Decree No. 109 ANKR.BK dated 19 August 2015 on the Organization and Functioning of the Ministry of Interior;
- Referring to the request of the Minister of the Ministry of Interior.

**HEREBY DECIDES**

**Article 1.\_**

The Cambodian Counter Counterfeit Committee (CCCC) was established to prevent all activities related to counterfeit products that harm to health and social safety in the Kingdom of Cambodia.

## **Article 2.\_**

The CCCC consists of the following members:

## **Article 3.\_**

The CCCC shall perform the following duties:

- Cooperate with relevant ministries and institutions for preparing the policies, strategies and action plans for preventing all activities related to counterfeit products that are harmful to health and social safety;
- Cooperate with relevant ministries and institutions for drafting relevant laws and regulations for preventing all activities related to counterfeit products that are harmful to health and social safety;
- Prepare action plans for training and straightening the capacity building of the officers in order to implement laws and regulations related to counterfeit products that are harmful to health and social safety;
- Prepare strategic plans and promote public awareness of the effects of counterfeit products in order to have a general understanding of the challenges and impacts aimed

at eliminating production, processing, export, import, sale, and the use of counterfeit products that are harmful to health and social safety;

- Initiate measures to combat counterfeit products that are harmful to health and social safety;
- Encourage the enforcement of laws and regulations related to counterfeit products that are harmful to health and social safety to be more effective;
- Cooperate with national and international institutions and development partners to support counter-counterfeiting activities related to counterfeit products that are harmful to health and social safety;
- Report on the implementation of work in each phase of actual duties to the Head of the Royal Government and the Minister of Interior;
- Perform other duties as assigned by the Head of the Royal Government.

**Article 4.\_**

The CCCC has right to use the seal of the Ministry of Interior to carry out their works.

**Article 5.\_**

The CCCC has a budget for the administrative works, and this budget is in the annual budget of the Ministry of Interior.

**Article 6.\_**

The CCCC has a Secretariat with the following structure:

- Administration
- Technical

The composition and procedures of the above secretariate shall be determined by a decision of the Minister of the Ministry of Interior.

**Article 7.\_**

The Decision No. 150 SSR dated 31 October 2014 on the establishment of the Cambodian Counter Counterfeit Committee, the Decision No. 29 SSR dated 11 April 2023 on the amendment and appointment of additional members to the Cambodian Counter Counterfeit Committee, Prakas of the Ministry of Interior No. 5619 BR.K dated 23 December 2014 on the organization and functioning of the Cambodian Counter Counterfeit Committee, Prakas of the Ministry of Interior No. 3309 BR.K dated 22 June 2023 on the amendment of the technical group of inter-ministries to support the Cambodian Counter Counterfeit Committee, and any regulations contrary to this decision shall be abrogated.
