**ON THE APPOINTMENT TO THE COMPOSITION OF THE
CAMBODIAN COUNTER COUNTERFEIT COMMITTEE**

- Having seen Royal Decree No. NS/RKM/0224/205 dated 21 February 2024 on the Appointment of Supplementary Composition of the Royal Government of the Kingdom of Cambodia;
- Having seen Royal Kram No. NS/RKM/0618/012 dated 28 June 2018 promulgating the Law on the Organization and Functioning of the Council of the Ministers;
- Having seen Royal Kram No. NS/RKM/0196/08 dated 24 January 1996 promulgating the Law on Establishment of the Ministry of Interior;
- Having seen the Sub-Decree No. 109 ANKR.BK dated 19 August 2015 on the Organization and Functioning of the Ministry of Interior;
- Having seen the Decision No. 35 SSR dated 6 February 2024 on the Establishment of the Cambodian Counter Counterfeit Committee;
- Referring to the request of the Minister of the Ministry of Interior.

HEREBY DECIDES

Article 1._
