**ON THE ESTABLISHMENT OF THE CAMBODIAN COUNTER**  
**COUNTERFEIT COMMITTEE**

**ROYAL GOVERNMENT**

- Having seen the Constitution of the Kingdom of Cambodia;
- Having seen Royal Decree No. NS/RKT/0913/903 dated 24 September 2013 on the Appointment of the Royal Government of the Kingdom of Cambodia;
- Having seen Royal Decree No. NS/RKT/1213/1393 dated 21 December 2013 on the Appointment of Supplementary Composition of the Royal Government of the Kingdom of Cambodia;
- Having seen Royal Kram No. 02/NS/94 dated 20 July 1994 promulgating the Law on the Organization and Functioning of the Council of the Ministers;
- Having seen Royal Kram No. NS/RKM/0196/08 dated 24 January 1996 promulgating the Law on Establishment of the Ministry of Interior;
- Having seen the Sub-Decree No. 16 ANKR dated 20 December 1993 on the Organization and Functioning of the Ministry of Interior;
- Referring to the necessity.

**HEREBY DECIDES**

## **Article 1.\_**

The Cambodian Counter Counterfeit Committee (CCCC) was established with the following compositions:

## **Article 2.\_**

The Cambodian Counter Counterfeit Committee shall perform the following duties:

- Cooperate with national and international institutions to combat counterfeit products that are harmful to health and social safety;
- Conduct research and investigate the sources of the import, production, stock and distribution of the counterfeit products;
- Educate public awareness of the effects of counterfeit products that are harmful to health and social safety;
- Crack down on all counterfeit products circulating in the Cambodian market by detaining suspects to prepare a case to be sent to the court for legal judgement;
- Conduct training, improving and straightening the capacity building of the officers and private sector parties;
- Report on the implementation of work in each phase of actual duties to the Deputy Prime Minister, Minister of the Ministry of Interior;

**Article 3.\_**

- The Cambodian Counter Counterfeit Committee has the right to use the seal of the Ministry of Interior to carry out their works;
- The Cambodian Counter Counterfeit Committee shall have a budget for the administrative works, and this budget is in the annual budget of the Ministry of Interior.

**Article 4.\_**

- The Cambodian Counter Counterfeit Committee shall have one secretariat;
- The Secretariat shall be headed by a chairman and shall have as many assistants as necessary. The officers of the Secretariat shall be an official within the Ministry of Interior and an official within the Ministry of various institutions of the Royal Government appointed on this committee. The appointment and procedures of the Secretariat shall be determined by a Prakas of the Ministry of Interior.

**Article 5.\_**

Minister in charge of the Council Ministers, Minister of Ministry of Interior, Minister of Ministry of Economy and Finance, Ministry of Civil Service, all ministers and directors and the composition above in the Article 1 shall implement this decision from the date of signature.
